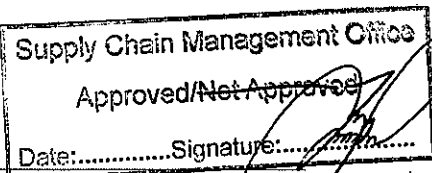

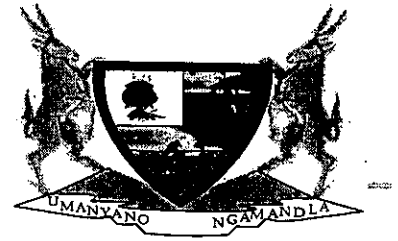

The promotion of literacy in disciplinary issues among supervision will serve to assist the Municipality in its greater goal of ensuring and maintaining a stable and productive labour environment.

Scope of Work

2. The appointed service provider will be expected to perform the following functions:
 - 2.1. Train identified staff on the provisions of the South African Local Government Main Collective Agreement in respect of collective and individual labour rights;
 - 2.2. Train identified staff on the implementation of the grievance procedure and the resolution of work-related disputes;
 - 2.3. Train identified staff on chairing and initiating disciplinary processes;
 - 2.4. Train identified staff on the provisions of the Labour Relations Act 66 of 1995, as amended, including the Code of Good Practice; and
 - 2.5. Train identified staff on Code of Conduct of Municipal Staff Members as provided in Schedule 2 of the Municipal Systems Act 32 of 2000.
