**Reasons for the proposed Extension:** During the month of March 2020 the president of the Republic of South Africa declared a national state of disaster due to the global outbreak of the Covid-19 pandemic. Following the declaration, a national lockdown was announced and implemented. This resulted in the country putting a stop to all economic activities that was being carried out with the exception of Health Services, Security Services, Cleaning Services, Disaster Management Services and Food Stores.

The Municipality has to adhere with the OHS Act of 1993, which requires the employer to bring about and maintain, as far as reasonably practicable, a work environment that is safe and without risk to the health of the workers. This means that the employer must ensure that the workplace is free of hazardous substances, micro-organisms, equipment and suitable, qualified and accredited security personnel. The act also declares that every CEO shall as far as is reasonably practicable ensure that the duties of his/her employer as contemplated in this Act, are properly discharged

The invitation to bid for security services was advertised on the 8<sup>th</sup> December 2020 and closed on 25<sup>th</sup> of January 2021, the bid was evaluated, and all the Bids were non-responsive, and it had to be re-advertised for the second time, due to the uncertainty and the length of time which will be taken when advertising the long term contracts the municipality therefore intends to extend the existing
