Notice is hereby given in terms of Section 116 (3) (a) and (b) of the Local Government: Municipal Finance Management Act, 2003 (Act 56 of 2003) that it is the intention of the Winnie Madikizela Mandela Municipality to amend the existing contract: Number: B/SM 16/16 Description: Provision of Travel Agency

**Service Providers: Turnimat and Iheans Travelling Agency**

**Reasons for the proposed Extension:** During the month of March 2020 the president of the Republic of South Africa declared a national state of disaster due to the global outbreak of the Covid-19 pandemic. Following the declaration, a national lockdown was announced and implemented. This resulted in the country putting a stop to all economic activities that was being carried out with the exception of Health Services, Security Services, Cleaning Services, Disaster Management Services and Food Stores.

This resulted in the municipality being unable to continue with accommodation services as a result of the lockdown regulations. With these regulations, new ways of doing government work were introduced which limited the amount of travel and contact sessions to date. It was around December 2020 after the initial announcement of the lockdown, travel and accommodation services were permitted to commence with restrictions that still made it a little unattractive for business to offer the services, however our service providers continued to honor their contracts.

As a result of the Disaster Management regulations still being implemented the contracted service providers lost close to a year on their contract, a need to request an extension of the existing contract for a period not exceeding twelve months was identified in order to allow the market to normalize before we can go out for new contracts. This is to cover for the time lost due to the national lockdown restrictions, a month for advertising and further month to for the finalization of the procurement processes and contract negotiations where necessary.
