

TENDER NOTICE

CLOSING DATE: WEDNESDAY, 17 NOVEMBER 2021 AT 12:00

Concor Mota-Engil Msikaba Joint Venture invites experienced EME and QSE **sub-contractors** to a tender briefing session for Sub-Contract **NRA N002-200-2016/2A – 22/26** for **Repairs of Provincial Roads between Ndwalane and Mtontsasa Police Station** on behalf of the South African National Roads Agency SOC Limited (SANRAL). This project is in the province of the Eastern Cape and in the local municipality of Ingquza Hill and comprises the following separate packages and estimated CIDB contractor gradings:

- Package 22 between Ndwalane and Ntafufu River Bridge (approximately 18,5 kilometres) by a grade 5CE contractor;
- Package 23 Lusikisiki bypass (approximately 4,8 kilometres) by a grade 6CE contractor;
- Package 24 between Lusikisiki and Zalu Quarry (approximately 14,0 kilometres) by a grade 6CE contractor;
- Package 25 between Bhukazi School and Flagstaff (approximately 14,0 kilometres) by a grade 6CE contractor; and
- Package 26 between Flagstaff and Mtontsasa Police Station (approximately 32,0 kilometres) by a grade 5CE contractor.

Preferences are offered to prospective tenderers from the targeted area, namely the Ingquza Hill, Port St Johns and Mbizana, as well as the CIDB grades and classes indicated for each sub-contract package. This tender will be evaluated in terms of functionality as a criterion and the price and preference points system.

Tenderers who satisfy the following criteria are eligible to submit tenders:

- a) B-BBEE Level 1 or 2 contributor.
- b) Exempted Micro Enterprise (EME) or Qualifying Small Enterprise (QSE).
- c) Registered on the National Treasury Central Supplier Database (CSD).
- d) Compliant with the Compensation for Occupational Injuries and Diseases Act (COID).
- e) Tax Compliant.
- f) Registered as “active” with the Construction Industry Development Board (CIDB) in the relevant contractor grade and class designation.

Note: CIDB grades that are one level lower as status PE will be considered for each package; thus, for an estimated CIDB 6CE sub-contract, bids from CIDB 5CE PE contractors will be accepted.

Notes to Tenderers:

- a) Concor Mota-Engil Msikaba Joint Venture will reserve the right to negotiate feasible rates with the preferred tenderers if necessary.
- b) Tenderers may submit tenders for all sub-contracts in this Tender Notice, but only 1 (one) subcontract will be let per preferred tenderer.

A compulsory information briefing meeting and a training session will take place at **SANRAL District Office, Ndwendwe Lodge, Flagstaff** on **Tuesday, 26 October 2021 at 10h00** where prospective tenderers shall meet the Project Management Team.

Tender documents will be made available at the information briefing in the form of a CD. The CD will contain an electronic copy of the tender document, in PDF format. Only the documents within the folder named “Returnable Document” must be printed, bound and completed with all the relevant supporting documents attached.

Tenderers must be represented at the information briefing meeting by a representative who must be the tenderer himself or an authorised person in the direct employment of the tenderer.

Late arrivals to the compulsory information briefing meeting will not be allowed access, and therefore will not be allowed to submit a tender. Such tenders received, shall be deemed non-responsive.

The tender and supporting documents shall be sealed in an envelope and clearly marked with the respective package identity as per the applicable sub-contract package:

“Sub-Contract NRA N002-200-2016/2A – ## for Repairs of Provincial Road between and – Package ...” and shall be **delivered by hand** to SANRAL District Office, Ndwendwe Lodge, Flagstaff between the hours 09:00 to 16:00 any date before the closing date and time.

Notes on delivered tenders:

- (a) Telephonic, telegraphic, telex, facsimile, e-mailed or electronic applications will not be accepted.
- (b) Tenders on multiple packages will only be accepted if each is individually identified with the respective package identity and each contains its separate supporting documents.

The Tender Documentation in this Tender Notice shall reach the stipulated address no later than 12h00 on Wednesday, 17 November 2021.
