CODE OF ETHICS WORKSHOP

1. Background

A Training Institute that possesses the unit standard ID number 113924 or 113960 with two references on Ethics accredited by the LGSETA or SAQA with suitable qualifications and experience are called upon to submit proposals to perform a Code of Ethics workshop to the newly elected councillors of the Winnie Madikizela Mandela Local Municipality.

2. Scope of work

Ethics workshop Proposals must include but not limited to, at least the following provisions

- 1. The workshop will be conducted on newly elected councillors;
- 2. Basic values and principles governing public administration and the Winnie Madikizela Mandela Local Municipality:
 - I.A high standard of professional ethics must be promoted and maintained;
 - II. Efficient, economic and effective use of resources must be promoted;
 - III. Public administration must be development-oriented;
 - IV. Services must be provided impartially, fairly, equitably and without bias;
 - People's needs must be responded to and the public must be encouraged to participate in policy-making;
 - VI.Public administration must be accountable;
- VII. Transparency must be fostered by providing the public with timely, accessible and accurate information;
- VIII. Good human-resource management and career-development practices, to maximise human potential, must be cultivated; and
