**Reasons for the proposed Extension:** Contract RT25-2016 was a contract that was introduced to all municipality with the introduction of MSCOA by National Treasury (NT). The contract had 7 ICT services providers or vendors for Enterprise Resource planning Systems which included Munsoft (PTY) LTD. The Municipality followed all processes and approvals by council and authorised by National treasury for the use of MUNSOFT (PTY) LTD as a preferred compliant financial system for the Municipality.

The current contract is ending on the last day of the month of November 2022. Preferential procurement Regulation, 2017, used by government entities for procurement has be put on hold, with the following conditions:

- Tenders advertised before 16 February 2022 be finalized in terms of the Procurement Regulations
- Tenders advertised after 16 February 2022 be held in abeyance; and
- No new tenders be advertised
