TERMS OF REFERENCE FOR REVIEWAL OF EXT3 DUMPING SITE CLOSURE, REHABILITATION & POST-CLOSURE MONITORING PLAN WITH FINANCIAL PROJECTIONS

1. INTRODUCTION:

Winnie Madikizela-Mandela Local Municipality has identified a need to review a closure and rehabilitation plan with financial projections for the disposal site that is currently being used. This is part of the obligation to the requirement by National Environmental Management Waste Act (No 59 of 2008). This is a plan forward by the municipality to prepare for the closure of the unauthorized site and to accomplish this goal; the municipality has to provide necessary steps and financial requirements which will have to be interpreted in the annual financial statements.

2. OBJECTIVES:

- Provision of guidelines of the site status quo.
- Provide guidelines to achieve closure of the site.
- Provide for rehabilitation of the site.
- Provide projected future plan for alternative use of entire rehabilitated land.

3. SCOPE OF WORK:

In order to achieve the development of the closure and rehabilitation plan the following points is understood to be key:

- Determination and specification of the site topographic plan.
- Determine site drainage plan.
- Assist in determining the source of cover material, especially for any required clay cover that may be necessary.

- Specify procedures for compaction testing of the “barrier layer” during its installation.
- Specify measures to minimize soil erosion and of the materials.
- Rehabilitation and landscaping plan.
- Financial Plan (3 years) from(1 July 2021 -30 June 2024) for closing, rehabilitation and post- closure monitoring of the dumping site.
- Propose future plans for the site.

4. DELIVERABLES:

A signed Closure, Rehabilitation and Post-closure monitoring Plan with Financial Projections for a period of 3 years starting (1 July 2021 -30 June 2024) shall be submitted in hardcopy and electronic version to the attention of the Municipal Manager Winnie Madikizela-Mandela Local Municipality.

All correspondences shall be directed to the Project Manager who will be introduced during the inception meeting.


