1. INTRODUCTION OF THE PROJECT

Wholesalers and retailers are an essential component of the South African rural economy as they provide vital goods, employment and an income to most rural dwellers. Despite this, the sustainability of wholesale and retailers particularly spaza shops has been problematic, with most closing down within the first few years of operation. This further increased by the influx or foreign operated spaza shops who are able to work together and buy in bulk. The needs analysis conducted by the municipality in the first quarter of the 2022/23 financial period identified existing gaps in the sector and recommends that wholesalers and retailers form a structure where they can share ideas and lobby government and the private sector for support. The structure would enable wholesalers and retailers to access funding from government schemes and private investors alike so that their operations are expanded and are sustainable. Some of wholesalers and retailers are classified as informal and make up a huge percentage of the proportion of our rural economy. Under the current challenging economic environment in South Africa, characterized by a rising cost of living and unemployment, wholesalers and retailers offer a viable alternative livelihood for many residents inour area.
