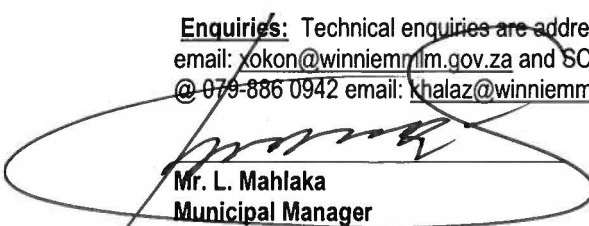

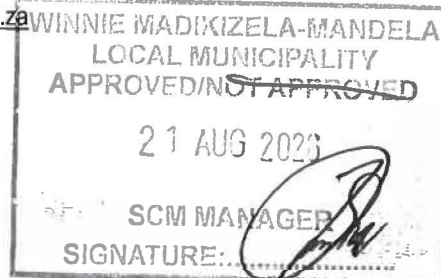

2. DEFINITIONS
